ACCESS STATEMENT

1.0 What is this Privacy Policy for?

- 1.1. This privacy policy is for this website [www.cluehqbrentwood.co.uk] and served by Cowen Edutainment Ltd trading as Clue HQ Brentwood] and governs the privacy of its users who choose to use it.
- The policy sets out the different areas where user privacy is concerned and outlines the obligations & requirements of the users, the website and website owners. Furthermore the way this website processes, stores and protects user data and information will also be detailed within this policy.

2.0 The Website
